If you have service time with another retirement system, you can report it from your online account at TCDRS.org or by calling TCDRS Member Services at 800-823-7782. We will verify your service time with the other system and credit it to your account. To see how much service time you have, sign in to your account at TCDRS.ORG.



As a TCDRS member, the

PROPORTIONATE RETIREMENT PROGRAM

lets you combine service time you earned in other Texas retirement systems with your TCDRS service time.

Combining your service time means you may be eligible for retirement earlier.

If you have an account with any of the retirement systems listed in this brochure, please call TCDRS Member Services.

WHO PARTICIPATES?

The Proportionate Retirement Program lets you combine service time you earned in any of the following Texas retirement systems to your TCDRS account:

- City of Austin Employees' Retirement System (COAERS)
- ★ Employees Retirement System of Texas (ERS)
- ★ Judicial Retirement System of Texas (JRS)
- ★ Teacher Retirement System of Texas (TRS)
- ★ Texas Municipal Retirement System (TMRS)

Service time from any of these systems counts toward your TCDRS vesting and retirement eligibility. However, your service time in other systems will not count toward your eligibility for TCDRS disability or survivor benefits.

If you were a depositing member of two systems at the same time, you may be able to count that service time only once. Combining your service time may mean you become eligible to retire sooner. You cannot combine money from different systems. If you retire from more than one system, you will get a separate monthly benefit from each system.

We RECOGNIZE SERVICE TIME

from other systems even if you withdrew your money.

WHAT TO DO

It is also a good idea to call the other system to let them know you have a TCDRS account. You may be eligible to apply your TCDRS service to eligibility requirements with the other system.
